2020 has been referred to as "the year that was", however together, with our Law Enforcement partners on the local, state and Federal level, along with our all-volunteer board of directors, our media partners and, of course the members of our communities, Metro Denver Crime Stoppers has continued to provide a valuable program that was designed to support our community leaders in keeping our communities safe during these times.

On behalf of the board of directors, we offer our warmest holiday wishes to you and those that you hold dear and as we move to 2021, we would like to remind everyone that we remain committed to increasing the safety of the Metro Denver community and we are looking forward to your continued support.

## **Highlights**

- MDCS Executive In 2019. the Board established Liaison Program. This а programmed was designed to provide clear and consistent communication and a single point of contact for our law enforcement partners and advisory board members and throughout 2020 we have continued to expand this program to provide mentorship to our internal board members as well as our NextGen board members.
- All current MDCS and NextGen board members have been tasked to complete a <u>Nonprofit Board Members Course</u> that was established by the Colorado Secretary of State Office. This course was designed as a resource for current and aspiring nonprofit board members and addresses important aspects of being an effective and responsible nonprofit director.
- Each year, the Aurora Chamber of Commerce hosts a luncheon to celebrate the communities <u>Unsung Heroes</u> and in 2020, MDCS Executive Board Member, Secretary Sarah Feldman Johnston was honored to be selected as a finalist.
- <u>Special Reward Cases</u> are cases in which the community (typically families & friends of victims) commit additional funds to offer as an award. In 2020 we have seen a net increase of over \$93,000.00 in donations related to Special Reward Cases, bringing our total to just under \$200,000.00 in special awards funds being held.

- Tips Received: 5008
- Cases Cleared: 382
- Arrests Made: 156
- Agencies/Departments: 137
- Rewards Paid: 164
- Rewards Approved: \$70,700.00
- Rewards Collected: \$43,200.00
- Volunteers: Over 250 volunteers and over 5,000 volunteer hours

Over 61% of the rewards approved were collected and just over 34% of the tipsters collected reward monies approved.

• <u>Supplemental Reward Cases</u> are cases that the law enforcement community has requested the reward amount be increased in an effort to further engage the community in assisting to solve a particular crime. Throughout the year, MDCS has committed over \$50,000.00 in additional funds to help solve these crimes.

#### Cold Cases & More....

**1980 – Douglas County Homicide & Sexual Assault** – this case was the first case solved by the newly established familial genetic DNA program. This case involved the death of Helene Pruszynski and resulted in the arrest, conviction and sentencing of James Curtis Clanton.

**1981 – Jefferson County Homicide** – this case utilized the familial genetic DNA program to assist in the identification of Donald Perea as the suspect of homicide victim – Jeannie Moore.

**1993 – Douglas County Homicide** – this case utilized the familial genetic DNA program to assist in the identification of a Jane Doe homicide victim – Rebecca Ann Redeker.

**1996 – Aurora Homicide** - this case involved the murder of Tangie Simms.

**2002 – Arvada Sexual Assault** – this case assisted in the identification of Brent Bloomquist as the suspect and resulted in his arrest.







## A Few Last Things...

## Did you know?

- Any case is a Metro Denver Crime Stoppers case... A tipster can provide information on any open case there
  doesn't have to be a crime alert issued by MDCS to be eligible for a reward or to remain anonymous the tip
  must go through Metro Denver Crime Stoppers.
- All information released by Metro Denver Crime Stoppers comes from our law enforcement partners and has been fully vetted and approved for public distribution.
- Metro Denver Crime Stoppers is not a law enforcement agency, receives no government funding and has no investigative authority.
- Metro Denver Crime Stoppers and our anonymous tipsters are protected by Colorado Revised Statute 16-15.7-101.
- All tipsters are eligible for a <u>Reward of UP TO \$2,000.00</u>. Only in cases where there is a verified special award listed and/or supplemental monies committed will a tipster have the potential receive over \$2,000.00.
- All Special Reward and/or Supplemental funding monies do expire. The expiration date should be listed within the Crime Alert and/or Press Release.
- The wording of news stories, press releases and crime alerts matter and we need everyone's assistance in getting the information out to the public in a clear, concise and accurate manner by adhering to the following:
  - Whenever possible use the MDCS Crime Alert template and only replace the text and photos related directly to the case.
  - Please refrain from listing other tip line phone numbers and/or detective phone numbers within the Crime Alert or Press Release this can cause great confusion and possibly put the tipster's identity at jeopardy.

We recommend the following wording when also promoting other tip lines and/or detective contact information; however, you can always reach out to a board member for assistance in wording:

Anyone with information please call Local Police 303 555 5555.

If you would like to remain anonymous and be eligible for a reward of up to \$2,000 you must contact Crime Stoppers 720 913 STOP (7867).

To be eligible for the award and to remain anonymous, tipsters must call the crime stoppers tip line.
